Determination of discount percentages for the debts of EOPYY to contracted private health services provider.

THE MINISTERS OF FINANCE – EMPLOYMENT, SOCIAL INSURANCE AND WELFARE – HEALTH

Having considered:

1. The provisions of par. 1a and 4 of article 34 of Law 4038/2012 “Emergency provisions concerning the application of the medium-term financial strategy framework 2010-2015” (Gov. Gazette 14A).
2. the provisions of article 17 of Law 3918/2011 “Structural changes in the health system and other provisions” (Gov. Gazette A, 31).
3. The provisions of articles 48, 52 and 90 of the P.D. 63/2005 (A/1998) “Codification of legislation for the Government and Governing Bodies”.
4. The P.D. 213/1992 (A 102) “Organisation of the General Secretariat of Social Insurance”.
5. The P.D. 95/2000 “Organisation of the Ministry of Health and Welfare” (Gov. Gazette A 76).
6. The P.D. 85/2012 (Gov. Gazette A 141) “Establishment and renaming of Ministries, transfer and abolishment of services”.
7. The P.D. 86/2012 (Gov. Gazette A 141) “Appointment of Ministers, Alternate Ministers and Deputy Ministers”.
8. The Decision No Y48//09-07-2012 “Determination of competencies of the Alternate Minister of Finance Mr. Christos Staikouras” (Gov. Gazette B 2105/09.07.2012).
9. The fact that this decision does not incur any expense to the State Budget, we decide:

The discount percentage granted on the transaction value (value of the relevant voucher not including the applicable VAT) which concerns the remaining debts of EOPYY to private health services providers is fixed as follows:

1. Diagnostic Centres–Laboratories:
 - (a) for a monthly debt not exceeding €15,000.00, a discount of 10%.
 - (b) for a monthly debt exceeding €15,000.00, a discount of 15%.
2. Private practices (clinics)
 - (a) for hospitalisation expenses, a discount of 8%.
3. Contracted Private Physicians:
 - (a) for a monthly debt not exceeding €4,000.00, a discount of 10%.
 - (b) for a monthly debt exceeding €4,000.000, a discount of 15%.

4. Suppliers of healthcare and other materials, a discount of 20% for expenses concerning special hospital materials (laparotomy materials, orthopaedic materials, transplants, artificial kidneys, materials for heart surgery, cardio-operative materials, intraocular lenses, breast pads, materials for angioplasty etc.).
5. Other contracting health services providers (physiotherapists, speech therapists etc.) a discount of 10%.
6. Pharmaceutical companies, a discount of 2%.

Existing debts are those for which the vouchers provided for in each case, have been issued until 31.10.2011.

The above debts are settled provided that:

- (a) the above discount referred to in each case is granted by the beneficiary – provider, with the production to EOPYY of the credit invoice and
- (b) a solemn declaration is filed by the beneficiary-provider, which will expressly state that he/she accepts the said settlement and waives any other claim, including default interest.
- (c) the beneficiaries - providers have not received 90% of the expenditure depicted on all vouchers which have been filed for clearance. In this case, there is no further debt of the State.

This decision must be published in the Government Gazette.
