Amendment of the Joint Ministerial decision No ΔΥΤ3(α)/οικ. 104747/2012 (Gov. Gazette 2883/B/2012) “Amendment of the Joint Ministerial Decision No Φ.42000/οικ.2555/353/B/2012) “List of diseases, whose medicines are administered with reduced or zero participation of the insured person” as amended by the Joint Ministerial Decision Φ.42000/οικ.12485/ 1481/6.6.2012 (Gov. Gazette 1814/B/2012)”.

THE MINISTERS OF EMPLOYMENT, SOCIAL SECURITY AND WELFARE – HEALTH

Having considered:

1. The provisions of article 38 of law 4025/2011 (reformation of Social Solidarity Agencies, Rehabilitation Centres, Restructuring of the NHS and other provisions” (Gov. Gazette A 228).
2. The provisions of article 90 of the legislative Code for the Government and the governing Bodies (P.D. 63/2005, A 98).
3. The provisions of the P.D. 86/2012 “Appointment of Ministers, Alternate Ministers and Deputy Ministers” (Gov. Gazette A 141).
4. The Decision No Y47/3.7.2012 of the Prime Minister (Gov. Gazette B 2105) “Assignment of competencies to the Alternate Minister of Health Marios Salmas” as amended by the similar decision No ΔΥ1α/οικ.78084/25.7.2012 (Gov. Gazette B 2339).
5. The Joint Ministerial Decision No Φ.42000 /οικ.2555/353/B/2012) (Gov. Gazette B 497) “List of diseases, whose medicines are administered with reduced or zero participation of the insured person”.
6. The Joint Ministerial Decision No Φ.42000/ οικ.12485/1481/6.6.2012) (Gov. Gazette B 1814) “Amendment of the Joint Ministerial Decision No Φ.42000/οικ.2555/353/B/2012) “List of diseases, whose medicines are administered with reduced or zero participation of the insured person”.
7. The Joint Ministerial Decision ΔΥΤ3(α)/οικ.104747/2012 (Gov. Gazette B 2883)

8. The fact that no encumbrance for the State's budget or the budgets of the insurance agencies is incurred by the provisions of this Decision, we decide:

After the first clause that follows subcase 19 of case B of the Joint Ministerial Decision ΔΥΓ3(α)/οικ.104747 the following clause is added:

Especially for the persons suffering from the diseases referred to in subcase 4 of case B, zero participation concerns the pharmaceutical preparations that concern the dealing with the disorders, complications and problems of health that may result from the above specific diseases and which are scientifically associated with those and provided that this is proven by the relevant medical opinion.

The second clause that follows subcase 19 of case B of the Joint Ministerial Decision ΔΥΓ3(α)/οικ.104747/2012 (Gov. Gazette B 2883) is amended and substituted as follows:

Patients having undergone transplant of solid or liquid organs and tissues, patients at the end stage of a chronic renal disease with renal dialysis, as well as paraplegics and quadriplegics do not pay any participation for all medicines administered for the treatment of their condition.

This decision must be published in the Government Gazette.
