List of pharmaceutical preparations administered by prescription and are not compensated by the Social Insurance Agencies.

THE ALTERNATE MINISTER OF HEALTH

Having considered:

1. The provisions of par. 1 of article 12 of Law 3816/2010 (Gov. Gazette 6/A/26.01.2010) as amended and in force.
2. The provisions of article 90 of the Code of Legislation for the Government and the governmental bodies which was ratified by article 1 of the P.D. 63/2005 (Gov. Gazette A 98).
3. The P.D. 95/2000 “Organisation of the Ministry of health and Welfare”, as amended and in force.
4. The P.D. 86/2012 (Gov. Gazette 141/A/21.6.2012) “Appointment of Ministers, Alternate Ministers and Deputy Ministers”.
5. The Decision No Y47/3-07-12 of the Prime Minister 9Gov. Gazette 2105/B/12) “Assignment of competencies to the Alternate Minister of Health Marios Salmas” as amended by the Decision No ΔΥ1α/οικ. 78084/25-07-12 (Gov. Gazette 2339/B/2012).
6. The provisions of article 35 of Law 3918/2011 (A 31).
7. The provisions of article 10 of Law 4052/2012 (Gov. Gazette A 41).

10. The fact that no expense is generated against the State Budget from this Decision, we decide:

The following list of pharmaceutical preparations which are administered by prescription and are not compensated by the Social Insurance Agencies, is approved.

EOF can, by its decision, transfer pharmaceutical preparations from the negative list to the category of non-prescribed medicines.

From the date this decision enters into force, the Joint Ministerial Decision ΔΥΓ3/οικ. Γ.Υ.153 (Gov. Gazette 544/B/1.03.2012) is abolished.

The above list is revised at the same time with the positive list of prescribed medicines and provided that its revision is deemed necessary, i.e. after the issue of the

General Price Bulletin and of the Corrective Bulletin thereof and within 60 days from the issue of the price bulletin containing new products.

The validity of this decision commences from the time the new Positive List of Prescribed Medicines enters into force and in any case within 15 days from the date of the publication hereof.

This Decision must be published in the Government Gazette.
