THE ALTERNATE MINISTER OF HEALTH

Having considered:

1. The provisions of par. 1 of article 12 of Law 3816/2010 (Gov. Gazette 6/A/26.01.2010) as amended and in force.

2. The provisions of article 90 of the Code of Legislation for the Government and the governmental bodies which was ratified by article 1 of the P.D. 63/2005 (Gov. Gazette A 98).

3. The P.D. 95/2000 "Organisation of the Ministry of health and Welfare", as amended and in force.

4. The P.D. 86/2012 (Gov. Gazette 141/A/21.6.2012) "Appointment of Ministers, Alternate Ministers and Deputy Ministers".

10. The fact that no expense is generated against the State Budget from this Decision, we decide:

The following list of pharmaceutical preparations which are administered by prescription and are not compensated by the Social Insurance Agencies, is approved.

Participation of patients for medicines whose price exceeds the amount of Euro 50, cannot be above 20% plus the normal participation.

From the date this decision enters into force, the Joint Ministerial Decision $\Delta Y\Gamma 3/01$ (Gov. Gazette 2141/B/26.09.2011) is abolished.

The above list is periodically revised after each issue of the General Price Bulletin and of the Corrective Bulletin thereof and within 60 days from the issue of the price bulletin containing new products.

The validity of this decision commences five (5) days after the issue of the Corrective Price Bulletin and in any case within 15 days from the date of the publication hereof. This Decision must be published in the Government Gazette.
