# THE MINISTER OF HEALTH

Having considered:

The fact that no expenditure is incurred against the State Budget from this decision, we decide:

Paragraph 2 of article 14 of the Ministerial Decision 3457 (Gov. Gazette 64/B/16-01-2014() is substituted by the following paragraph: The classification of medicinal products in clusters with the same active substance and pharmacotechnical form is made in accordance with the provisions of articles 1 and 2 of the Ministerial Decision  $\Delta Y\Gamma 3(\alpha)/01$  (Gov. Gazette 2912/B/30-10-2012) as amended by the Ministerial Decision 82961 (Gov. Gazette 2219/B/09-09-2013). The reference price in each cluster with medicinal products with the same active substance and pharmacotechnical form is determined for every available alternative content (strength). In order to calculate the Reference Price, the provisions of article 3 of the Ministerial Decision  $\Delta Y \Gamma 3(\alpha) / \alpha \kappa . 104744$  (Gov. Gazette 2912/B/30-10-2012) as amended by the by the Ministerial Decision No  $\Delta Y \Gamma 3(\alpha)/\alpha$ . (Gov. Gazette 3356/B/17-12-2012) and Ministerial Decision 82961 (Gov. Gazette 2219/B/09-09-2013). In order to calculate the Reference Price, the provisions of par. 2 of article 3 of the Ministerial Decision No  $\Delta Y\Gamma 3(\alpha)/0$  (Gov. Gazette 3356/B/17-12-2012) apply on generics with a lower daily treatment cost (DTC), that account for 20% of the total sales in terms of volume of generics of the specific cluster, per strength. More specifically, the generics are classified based on the DTC in increased order, starting from the medicinal products with the lower DTC and continuing to the immediate next, until the medicinal product with the highest DTC. The Reference Price results next, as the weighted average of the generics with the lower DTC that account for 20% in sales during the last six months before the calculation of the prices, among the generics of the occasional cluster and per strength. Sales derive based on the expenditure for EOPYY. In case the patient selects a medicinal product

with a retail price that coincides with the insurance price, the patients mays the enacted participation percentage. In case a medicinal product with a retail price higher than the one reimbursed is selected, the patient covers, apart from his/her enacted participation, the total difference between the reimbursement price and the retail price of the medicinal product. In the cases where the retail price of the medicinal product is lower than the reimbursement price, the difference between the retail price and the reimbursement price is deducted from the enacted participation of the patient provided for, up to the half thereof.

# Decision No oik. 38714

Provisions for the sale and pricing of OTC medicinal products

# THE MINISTER OF HEALTH

Having considered:

16. The fact that no expenditure is incurred against the State Budget from this decision, we decide:

1. The prices of the OTC medicinal products as concluded by the occasional issue of the prices bulletin, according to the existing provisions, are the maximum prices.

2. Manufacturers, packers and importers may grant unlimited discount on the exfactory price to the wholesalers, pharmacists and partnerships and public or private hospitals, for OTC medicinal products.

3. The wholesalers may grant unlimited discounts on the wholesale price to the pharmacists and hospitals, for the OTC medicinal products, provided that such discount will be recorded on the sales invoices.

4. Pharmacists may sell the OTC medicinal products at prices unlimitedly lower than the maximum prices, as the latter are fixed in the occasional medicinal products prices bulletin, provided that such discount will be recorded on the sales invoice.

4. Transactions between manufacturers, packers, importers, wholesalers, pharmacists, partnerships and public or private hospitals that concern OTC medicinal products, are conducted at arm's length and are not subjected to any restriction or mandatory credit. More specifically, in the Ministerial Decision 3457/16-1-2014 (Gov. Gazette 64) in article 4, the two-months credit set out in par. 3 and 4 does not apply to the OTC

medicinal products, as well as the provisions of article 9. In addition, in the Ministerial Decision 325/5851/22-1-2014 (Gov. Gazette 88) and in article 4 thereof, the two-months credit set out in par. 3 and 4 does not apply for the OTC medicinal Products as well as the provisions of article 9.

This Decision enters into force from the date following its publication in the Government gazette.

This Decision must be published in the Government Gazette.
