

SFEE's REPORT ON STATE'S DEBTS TOWARDS SFEE's MEMBER-COMPANIES

Sales, amounts paid and amounts due until 30.03.2015

Athens, April 2015

The Hellenic Association of Pharmaceutical Companies (SFEE) collected and analyzed all the available data regarding pharmaceutical debts of the state to its member-companies, for the invoices issued from 01.01.2014 up until 30.03.2015. The analysis describes both in detail the data regarding sales, sums that have been paid and sums that are still pending (owed) for invoices issued from 01.01.2014 up until 30.03.2015, and collectively for 2014 and 2015 for the pharmaceutical sector only.

Moreover, data on pending debts from NHS hospitals, EOPYY (IKA), military hospitals and IFET towards SFEE member-companies for invoices issued before 01.01.2014 were collected and included in the analysis.

- The total amount of sales, sums collected and sums that are pending will be presented in table 1. These sums refer to all invoices issued each year (from 01.01.2014 up until the 30.03.2015).
- At Table 2 the total amount of sales, sums collected and sums pending will be presented. These sums refer to all invoices issued up until the 31.12.2014. Total debts that are presented include sums pending prior to the year 2014.

It is stressed that Tables 1, 2 include only member-companies that send a detailed list of debts. Therefore these tables refer to a percentage of debts (nearly 80%).

- For 2014, 62% of total debts from public hospitals & 36% from EOPYY respectively have been paid back.
- On the contrary, for 2015 up until 30.04.2015 there have been no payments from any of the providers (only 1% of total debts has been paid back).

Table 3, total amount due from NHS hospitals EOPYY (IKA), and Military Hospitals will be presented. The sums reported include also aggregate debt data from member-companies of SFEE.

On 30.03.2015, total amount of the state's debt towards SFEE's member - companies was €1.028 million, showing an increase from previous month of approximately 8%, mainly attributable to settlement stagnation of outstanding debts for 2014 from EOPYY (delays up to 10 months) and 2015.

 On this note, our companies are more than 12 months behind in payments in contrast to the rest of the providers, without having any payment plan from the authorities for the past 5 months.
